- The bids will be opened in the presence of Bidders' representatives who choose to attend at **B.S. 2076-09-28, 1:00 P.M.** at the office of **Sakela Rural Municipality Office** Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format amounting to a minimum of **as specified in clause no.: 8**, which shall be valid for 30 days beyond the validity period of the bid (**i.e. 120 days**).
