- Sealed or electronic bids must be submitted to the office Sakela Rural Municipality, Khotang by hand/courier or through PPMO website www.bolpatra.gov.np
 (as specified in clause 9). on or before 12:00 Noon on 2075/09/06. Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 PM on 2075/09/06 at the office of Sakela Rural Municipality, Khotang. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of amount specified in clause 9, which shall be valid for 30 days beyond the validity period of the bid (i.e.120 days from bid submission date)
- 6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 7. Any bidder may submit the bid either singly or as partner in J/V provided that each J/V partner has purchased the bid document separately.
