- 5. Electronic bids must be submitted to the office *Sakela Rural Municipality Mattim*, *Manebhangyamg* through PPMO website www.bolpatra.gov.np/egp on or before B.S. <u>2076-12-11</u> <u>12:00 P.M</u>. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **B.S.** 2076-12-11, 1:00 P.M at the office of **Sakela Rural Municipality Office** Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format, amounting to a minimum of as secified in clause no: 8, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days)
